If the problem cannot be solved in this manner the customer furnishes a contact name, ship-to address and telephone information and Master Card or Visa Card Credit information to the Technical Service Representative. The Technical Service Representative will immediately ship a Replacement Service Exchange Unit via ground service.

NOTE: The Credit Card will only be charged under the following circumstances:

- 1) If during the warranty period the unit failure is due to misuse, abuse, neglect or unauthorized alterations or repairs or the failed unit is not received back within 14 days.
- 2) If the unit failure is outside the warranty period.
